Studio5Social (“We”) are committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. What do I do with your information?

The data collected on the contact form is your name and email address which I then use to contact you following your request for me to do so. If you decide to give your phone number in the comments box and ask me to contact you via telephone then I shall do so. When you browse the website, I automatically receive your computer’s internet protocol (IP) address in order to provide me with information that helps me to learn about your browser and operating system.

When you visit the studio5social website, I automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the site, I collect information about the individual web pages or products that you view, what websites or search terms referred you to the site, and information about how you interact with the site. I refer to this automatically-collected information as “Device Information”

“Cookies” are data files that are placed on your device or computer and often include an anonymous unique identifier. For more information about cookies, and how to disable cookies, visit <http://www.allaboutcookies.org>.

“Log files” track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.

“Web beacons”, “tags”, and “pixels” are electronic files used to record information about how you browse the Site.
